## AUDITOR'S REPORT

(Pursuant to the Canada Elections Act)

To the Natural Law Party Fund  
Chief Agent of the Natural Law Party of Canada

We have audited the Registered Party's statement of assets and liabilities of the Natural Law Party of Canada at December 31, 2000 prepared in accordance with the Canada Elections Act. This return is the responsibility of the chief agent of the party. Our responsibility is to express an opinion on the return based on our audit.

We conducted our audit in accordance with generally accepted auditing standards. Those standards require that we plan and perform an audit to obtain reasonable assurance whether the return is free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the return. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall presentation of the return.

In our opinion, this statement presents fairly, in all material respects, the financial position represented in the accounting records on which the statement is based in accordance with the requirements of the Canada Elections Act.

The Canada Elections Act does not require us to report, and we have not reported, on the completeness of the accounting records on which the statement is based.
