(Pursuant to Sections 555(2), 555(1b) & 555(1c) of the Canada Elections Act)



I have audited the balance sheet of the New Democratic Party as at December 31, 2000 which is a consolidation of the balance sheet for the federal office, the ten provincial sections and the three territorial sections. This balance sheet is the responsibility of the Chief Agent of the Party. My responsibility is to express an opinion on this statement.

My audit, of the balance sheet of the New Democratic Party Federal Office, was conducted in accordance with generally accepted auditing standards. Those standards require that I plan and perform an audit to obtain reasonable assurance whether this statement is free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in this statement. An audit also includes assessing the accounting principles used and significant estimates made by management. For the remaining New Democratic Party organizations, I have relied on the reports of the auditors who have examined these financial statements.

All of the financial report on which I have relied were audited and unqualified except for a general limitation on the verification of revenue - that it was not possible because of the nature of revenue, to verify income beyond accounting for the receipts as recorded in the books. Generally, examinations were not designed to determine the extent of omissions, if any, from the accounting records.

In my opinion, subject to the above limitation, this balance sheet as at December 31, 2000 presents fairly the information contained in the accounting records on which it is based in accordance with generally accepted accounting principles.


