In our opinion, except for the effect of adjustments, if any, which we might have determined to be necessary had we been able to satisfy ourself concerning the completeness of contribution income and expenses, these financial statements present fairly, in all material respects, the financial position of the Libertarian Party of Canada as at December 31, 2008 and its income and expenses for the year then ended in accordance with the accounting requirements of the Election Finances Act and the guidelines issued by the Chief Electoral Officer as disclosed in the notes to the financial statements.
