(b) a report on that statement made by the registered party's auditor to its chief agent that contains the auditor's opinion as to whether that statement presents fairly and in accordance with generally accepted accounting principles the information on which it is based; and

(c) a declaration in the prescribed form by the chief agent of the registered party concerning that statement.

The personal information provided is for federal electoral purposes only. This information may be made available for public inspection pursuant to section 541 of the *Canada Elections Act*. This information will be published by the Chief Electoral Officer pursuant to section 412 of the *Canada Elections Act*. The Elections Canada Web site (www.elections.ca) may be the medium chosen for this publication. The information is retained in personal information bank CE0 PPU 010.

AUDITOR'S REPORT

To the chief agent of the
ANIMAL ALLIANCE ENVIRONMENT VOTERS PARTY OF CANADA

I have audited the statement of financial position of the ANIMAL ALLIANCE ENVIRONMENT VOTERS PARTY OF CANADA as at December 09, 2005. This financial statement is the responsibility of management. My responsibility is to express an opinion on this financial statement based on my audit.

I conducted my audit in accordance with Canadian generally accepted auditing standards. Those standards require that I plan and perform an audit to obtain reasonable assurance whether the financial statements are free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the financial statements. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall financial statement presentation.

In common with many political parties, the ANIMAL ALLIANCE ENVIRONMENT VOTERS PARTY OF CANADA derives revenue from donations, the completeness of which is not susceptible to satisfactory audit verification. Accordingly, my verification of these revenues was limited to the amounts recorded in the records of the party and I was not able to determine whether any adjustments might be required to revenues, excess of revenues over expenditures, assets, liabilities and funds.

In my opinion, except for the effect of adjustments, if any, which I might have determined to be necessary had I been able to satisfy myself concerning the completeness of the receipts referred to in the preceding paragraph, this financial statement presents fairly, in all material respects, the financial position of the ANIMAL ALLIANCE ENVIRONMENT VOTERS PARTY OF CANADA as at December 09, 2005 in accordance with Canadian generally accepted accounting principles.
